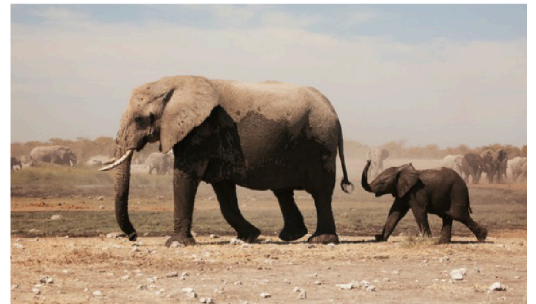

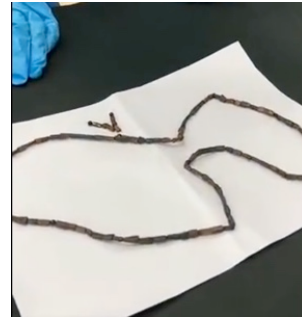

Six Suspects were Convicted of Harming Rare and Endangered Wild Animals

Shenzhen Longgang District People's Court Judged Three Criminal Cases Involving Pangolins

Shandong Police Carried Out a Series of "Kunlun" Special Operations
