## The Second Branch of the Hainan Provincial People's Procuratorate Prosecuted Suspect Xing and 26 Other Offenders in the Case of Illegal Hunting, Acquisition, and Sale of Terrestrial Wild Animals

### Yun County People's Court, Yunnan Province, Pronounced a Verdict in a Case of Illegal Owls Hunting , One Person Was Sentenced

## Luannan Court, Hebei Province, Pronounced a Verdict on a Case of Illegal Acquisition of 51 Protected Birds, One Suspect Was Sentenced

## Yinchuan Railway Transport Court Pronounced the Verdict of Two Wildlife Crime Cases, 12 Suspects Were Sentenced

**Reason for Seizure:** Illegal hunting, acquisition, and sale

**Number of Offenders:** 12

**Case Progress:** Defendants Chen and Luo illegally purchased and sold endangered wild animals and wildlife with important ecological, scientific and social value, and their acts constituted the crime of harming endangered wild animals and the crime of concealing criminal proceeds, and sentenced defendant Chen to eight years imprisonment and a fine of CNY 75,000, and sentenced defendant Luo to four years and ten months imprisonment and a fine of CNY 40,000. Defendants Yang, Li, and others constituted the crime of illegal hunting, and were sentenced to imprisonment ranging from four years to ten months. The defendant was sentenced to pay damages ranging from CNY 16,000 to CNY 980,000.

## Hong Kong SAR

### **Hong Kong Customs seizes suspected scheduled dried shark fins**



Hong Kong Customs seized over 450 kilograms of dried shark fins which included suspected scheduled dried shark fins of endangered species with an estimated market value of about \$1.3 million at Hong Kong International Airport.

A 38-year-old female passenger arrived at Hong Kong from Brazil via Ethiopia yesterday. During customs clearance, Customs officers found the batch of dried shark fins in her 15 check-in baggage. Upon verification, officers of the Agriculture, Fisheries and Conservation Department (AFCD) confirmed some of the dried shark fins are endangered species under the Protection of Endangered Species of Animals and Plants Ordinance.

The case was handed over to the AFCD for follow-up investigation. Customs reminds members of the public not to carry controlled items into and out of Hong Kong.

Under the Protection of Endangered Species of Animals and Plants Ordinance, any person found guilty of importing or exporting an endangered species without a licence is liable to a maximum fine of \$10 million and imprisonment for 10 years.

## Hong Kong Customs detects suspected case of smuggling scheduled dried shark fins from air passenger



Following the detection of a suspected case of smuggling scheduled dried shark fins from an air passenger at Hong Kong International Airport on November 23, Hong Kong Customs on November 24 detected another similar case and seized over 450 kilograms of dried shark fins, including suspected dried shark fins of scheduled endangered species with an estimated market value of about \$1.3 million at the airport.

A 35-year-old male passenger arrived at Hong Kong from Brazil via Ethiopia on November 24. Upon arrival, he made a Customs declaration for the batch of controlled items and presented an image of a Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) document to Customs officers. The documents were later confirmed invalid by officers of the Agriculture, Fisheries and Conservation Department (AFCD). AFCD officers later confirmed some of the dried shark fins in his 15 pieces of check-in baggage are of endangered species listed in CITES Appendix II and regulated under the Protection of Endangered Species of Animals and Plants Ordinance (the Ordinance).

It was discovered in both cases that crime syndicates not only attempted to use forged or invalid documents, but also deliberately sourced dried shark fins that were yet to be regulated and mixed them with the scheduled ones in order to evade detection.

The Government has gazetted the amendment to the Ordinance to bring more shark species under the control of the Ordinance from December 15, 2023 onwards. The Customs and the AFCD will continue to take vigorous enforcement action to combat smuggling of endangered species.
