

Case Progress: Defendant Lou was convicted of the crime of harming precious and endangered wildlife, sentenced to fixed-term imprisonment of one year and two months, with one year and six months' probation, and fined CNY 8,000 (fine already paid).

The involved Chinese Hwamei and Bamboo Partridge have all been released into the wild in the forest near Waosu Reservoir.
